was made by staff because of safety concerns. Library officials are committed to embracing diversity and inclusion of all residents and have funded staff initiatives for this purpose. She stated that first and foremost, the library is here to serve our community and that library trustees solely make decisions in the best interest of the community.

- 10.17.02 **PUBLIC COMMENT** - Ms. Rottenberg would appreciate the library rescheduling the recently canceled Know Your Rights workshop. Longtime resident Ms. Harp thanked the board and acting executive director for responding to the growing and ever changing community. Mr. Walsh commented on library service changes referenced in a recent Public Library Association (PLA) program schedule. Former employee Ms. Smolin wanted to learn the direction of the current leadership and be sure staff are recognized and appreciated by the community. Employee Sonya Hill showed support by sharing she believes Acting Executive Director Mike Driskell and Shannon Distel have always listened to and advocated for their staff. Mr. Cortopassi expressed sadness with the departure of Deputy Director Jeremy Andrykowski and hopes the library is moving in a good direction, as it has in the past. Ms. Patel praised the library's diversity initiatives and the library board members. Mr. Olson thanked the board for the diligent and passionate work around the Know Your Rights program and subsequent rally. School Services Coordinator Julie Jurgens spoke against the restructuring and showed support of the board for pursuing a change of leadership, pointing to concerns of the upcoming PLA presentation. Mr. Bertucci spoke in support of the current board leadership and remarked the board's role is to ensure the executive director follows through with the board's policies and community's desires.
