Re: Policy 7.007 Flag Display on Library Property

The Board of Library Trustees approved Policy 7.007 Arlington Heights Public Library Flag Policy at the May 17, 2022, Board of Library Trustees meeting. This policy outlines the display of flags other than the U.S. and State of Illinois flags on library property.

Since meeting, the board president, library staff and library attorney have worked to review and fine tune the policy to ensure consistency and clarity of the intent and expectations of the library board, staff and community.

Attached is the original policy approved at the May 17, 2022, board meeting for your reference, and a draft containing revisions to the approved policy for discussion. This draft contains the information included in the approved policy, as well as some additions to help clarify the selection process and criteria.

If time beyond this meeting is needed to review and edit Policy 7.007, a resolution is also attached which the board may adopt to provide the ability to fly the pride flag in June with no further approved changes to the adopted policy.

### 7.007 ARLINGTON HEIGHTS PUBLIC LIBRARY FLAG POLICY

#### **PURPOSE**

The library has a flagpole located at the front of the library's property. This flagpole flies the United States flag, the State of Illinois flag, and the Village of Arlington Heights flag is not flown as well as additional flags chosen by the library as an expression of the library's mission, core values or official segments. The library's flagpoles are not intended to serve as a forum for free speech by the public. Instead, the flagpoles are to fly library flags which are selected by the library, and to serve as a government forum for expression of the library's missions, core values and official segments, as recognized by the U.S. Supreme Court decision *Shurtleff et al. v. City of Boston*.

The policy will provide the provisions governing the display of the flag found in the U.S. Code, Title 4, Chapter 1, and the Illinois Flag Display Act 5 ILSC 465.

The library director will oversee the administration of the flagpoles.

When selecting the flags to be flown on the flagpole, the library will consider the following:

- Whether the United States or the State of Illinois has recognized the flag through a statute or proclamation;
- Whether the flag represents a national, state, or village interest and is consistent with the library's mission, core values or official segments;
- Whether the flag represents a positive interest or value worthy of public recognition and is consistent with the library's mission or official sentiments.

## 7.007 USE OF FLAGS ON LIBRARY PROPERTY ARLINGTON HEIGHTS PUBLIC LIBRARY FLAG POLICY

### **PURPOSE**

The Board of Library Trustees adopts this Policy 7.007 as the flag policy of the Arlington Heights Memorial Library.

The library has two a flagpoles, i.e., a flagpole located at the front of the library's property at 500 North Dunton Avenue and another at 112 North Belmont (Makerplace).

Generally, flags on library flagpoles are one or more of the following:

- 1. The United States flag;
- 2. The State of Illinois flag;
- 3. The Village of Arlington Heights flag;
- 4. National League of Families POW/MIA flag.

The library will follow provisions governing the display of the flags found in the United States Code, Title 4, Chapter 1, and the Illinois Flag Display Act 5 ILSC 465.

Other flags: From time to time, the board may approve flying other flags. Any flags approved by the board shall represent This flagpole flies the United States flag, the State of Illinois flag, and the Village of Arlington Heights flag is not flown as well as additional flags chosen by the library as an expression of the library's official sentiments or the library's mission, vision and core values or official segments. The library's flagpoles are not intended to serve as a forum for free speech by the public. Instead, the flagpoles are to fly library flags which are selected by the library, and to Flags flown on the library's flagpoles will be approved by the board and serve as a government forum for expression of the library's missions, vision, core values or and official sentiments (government speech) segments, as was recognized by the U.S. United States Supreme Court in its decision in Shurtleff et al. v. City of Boston.

The library does not fly flags at the request of the public, any organization, or any individual. Use of a library flagpole is not intended to serve as or create a forum for free expression by the public.

The policy will provide the provisions governing the display of the flag found in the U.S. Code, Title 4, Chapter 1, and the Illinois Flag Display Act 5 ILSC 465.

The library director will oversee the administration of the flagpoles.

When approving selecting the flags to be flown on the library flagpoles, the board library will consider the following:

- 1. Whether the United States or the State of Illinois has recognized the flag or cause through a statute or proclamation or other official communication, e.g., National Heritage Months or National Awareness Months;
- 2. Whether the flag represents a national, state, or local village interest and is consistent with the library's mission, vision, core-values or official sentiments segments;
- 3. Whether the flag represents a positive interest or value worthy of public recognition and is consistent with the library's mission, vision, values or official sentiments.

The board will express its approval of flags on library flagpoles either by a written resolution or by majority vote of the Board of Library Trustees which majority vote will be documented in the minutes of a board meeting.

**Subject: Flag Policy** 

Greetings Trustees,

A few issues have come up and become apparent with the Flag Policy that I want to update all on and the next steps. Please do not reply to this email because of the Open Meetings Act.

- 1. First off, the policy that we were listening to on Tuesday night was a draft. The Glenview Public Library approved an updated one on Thursday night. Roger is already in contact with their lawyer to get a new version to determine what changes were made and if they are ones that we need to also consider.
- 2. We never approved the Pride flag to be flown. While it was discussed there was never a decision on what flags to fly. The vote was simply on the policy.
- 3. The policy does not indicate the mechanism of how the Library will determine and select the flag. Does that mean the Board votes on it or the staff decides or the Executive Director decides or we set up a special commission for determining it or is there something else? That has to be determined.
- 4. We also need to determine who pays for these flags. Do they become a separate budget item or perhaps we work with the Friends or the Foundation?

There are a lot of unanswered questions that need to be buttoned up. I have already spoken with Roger to review the policy to make sure that legally it is as sound as it can be. I have also asked him to explore options on solidifying the actual mechanism on making this decision. We should have this by early next week.

If the Pride flag is to be raised by June 1<sup>st</sup>, or as Trustee Somary mentioned to me tonight, have the POW/MIA flag flown on Memorial Day, we will have to have a special meeting in order to determine these steps. Janet will be contacting you to find what dates will work. I will also ask Roger if he can be present at this meeting.

Hi Debbie,

As requested, below is the information I was told by the Secretary of State's Office of General Counsel regarding the state of Illinois' policies and procedures for flying specific flags at the State Capitol:

The only law in Illinois statute regarding flag flying is a requirement that the state flies the US flag, the state flag, and the POW/MIA flag. The Secretary of State's office is in charge of flying the flags at the Capitol. They will only fly additional flags if they receive a request from the Governor's office to do so. They do not fly flags that are requested by private citizens. That way, the flag is considered government speech, not a public forum, because the request came from the Office of the Governor. The General Counsel's office stressed that there must be a record of the request from the governmental office. For the Sec. of State, that's the written request from the Governor's Office. For local boards like the Arlington Heights Memorial Library board, Counsel said it could be a record of the request and approval in Board meeting minutes.

In the Supreme Court Opinion in *Shurtleff v. Boston*, Justice Breyer (writing for the majority) nodded towards Boston flying a Pride flag as government speech because it "reflect[s] particular city-approved values or views" (pg. 10 of the Opinion). With that in mind, I also asked the General Counsel to clarify for me if it was his interpretation that flying a Pride flag could also be government speech if it's an expression of an organization's stated policies like a DEI policy. I asked that question specifically regarding AHML and the Library's policies. Counsel agreed with me that it would also be government speech for that reason, and stressed that the decision to fly a specific flag should come from the Library Board and there should be a record that it originated from the Board, as mentioned above.

I further clarified if the government speech rule would still apply if the request came from a Board Member. He agreed it would be if that Board Member made the request as part of their official duties. So, your request as a Board Member at the previous AHML Board meeting would comply with these requirements.

That is the information I received from my call with the Sec. of State's General Counsel office. All of that information was shared with Greg Zyck when I spoke with him about adopting a flag policy on the morning of 5/17.
