FOL Membership

The Friends membership year runs from April 1 to March 31. Did you know that any membership that begins on October 1 or later is automatically extended into the next membership year? So if you sign up for a membership now, it will be good until March 31, 2025. Consider it an early holiday gift from the Friends!

Tax-Smart Giving

If you are over 70½ years old and have a traditional IRA, you can make a Qualified Charitable Distribution (QCD) to the Friends of the Library. A QCD is a direct transfer of funds from your IRA custodian to a qualified charity. It is a tax-smart way to give to charity because it excludes the amount donated from your taxable income. Donations must be made by December 31 to be applied to this year's taxes.

To make a QCD to the Friends, simply contact your IRA custodian and provide them with the following information.

- **The name** of the charity: Friends of the Arlington Heights Memorial Library
- **The address** of the charity: 500 N. Dunton, Arlington Heights, IL 60004
- **The amount** you want to donate
- **Your date of birth**

That's all there is to it! Your donation will be used to support the AHML.



There are a number of benefits to making a Qualified Charitable Distribution.

- **Reduce your taxable income.** QCDs are excluded from your taxable income, which can lower your overall tax bill. This is especially beneficial if you are in a high tax bracket.
- **Satisfy your RMD.** QCDs can be counted towards satisfying your Required Minimum Distribution (RMD) for the year. This means you can use QCDs to meet your RMD requirement and give to charity at the same time.
- **Give to charity without itemizing.** QCDs do not require you to itemize your deductions on your tax return. This can be beneficial if you do not have enough other deductions to itemize.

If you wish to make a Qualified Charitable Distribution to the Friends of the Arlington Heights Memorial Library, contact your IRA custodian with the required information. Your IRA custodian will transfer the funds directly to the Friends. Please confer with your accountant about your individual tax situation. Contact your IRA custodian or your accountant for more information.
