MINUTES OF THE REGULAR MEETING OF THE BOARD OF LIBRARY TRUSTEES OF THE ARLINGTON HEIGHTS MEMORIAL LIBRARY HELD ON TUESDAY, FEBRUARY 20, 2024.

- 02.24.01 A regular meeting of the Board of Library Trustees of the Arlington Heights Memorial Library was called to order in the Richard Frisbie Board Room of the Arlington Heights Memorial Library on Tuesday, February 20, 2024, at 7:00 p.m. by President Amy Somary.
- 02.24.02 Upon <u>**ROLL CALL**</u>, the following answered Present: Trustees Galla, Kelly, Medal, Zyck and Somary. Trustee Borrell participated in the meeting via Zoom due to unexpected childcare obligations.

Absent: Trustee Ruhl

Also present: Michael Driskell, Executive Director; Sasha Vasilik, Director of Communications and Marketing; Traci Sara, Finance Manager; Diane Marshbank Murphy, Digital Services Manager; Bill Pardue, Digital Services Librarian; Teresa Katsogianos, Administrative Assistant and Janet Moravec, Executive Administrative Assistant. Dana Revilla, Deputy Director, participated in the meeting via Zoom.

- 02.24.03 President Somary led the **PLEDGE OF ALLEGIANCE**.
- 02.24.04 There was no **PUBLIC COMMENT**.

02.24.05 LIAISON REPORTS

- FRIENDS OF THE ARLINGTON HEIGHTS MEMORIAL LIBRARY – Executive Director Michael Driskell reported there was no report from the Friends.

- ARLINGTON HEIGHTS MEMORIAL LIBRARY FOUNDATION – Mr. Driskell reported the Arlington Heights Memorial Library Foundation hosted a successful fundraiser "Date Night, Just the Two of Us" at the Makerplace. The Foundation will be celebrating International Woman's Day on March 8 at the Makerplace showcasing local women entrepreneurs. The Foundation continues to meet with their Advisory Team to share their Impact Report, the new Scholarship flyer and the latest campaign to raise funds for a new bookmobile.

- 02.24.06 Trustee Zyck moved <u>APPROVAL OF THE MINUTES OF THE REGULAR BOARD</u> <u>MEETING OF JANUARY 16, 2024 (Action Item 1)</u>. Trustee Galla seconded. All were in favor and the minutes were approved as submitted.
- 02.24.07 **REVIEW OF THE FINANCIAL REPORT FOR THE PERIOD ENDED JANUARY 31, 2024 (Item 2)** – Mr. Driskell reported there was no real estate tax revenue recognized for the month of January. While cash may be collected in January from the delayed second installment tax bill, it would be booked as an adjustment to 2023 for accounting purposes since that is the period to which that revenue relates. The library received personal

property replacement taxes (PPRT) in the amount of \$32,480.23. The library received \$31,849.03 in interest income in January. With 8% of the fiscal year lapsed, 11% of the unaudited annual operating budget has been expensed. In January, prepaid expenses for annual contracts (such as insurance premiums for the new year) and commodities are typically higher than the rest of year, yielding expense percentages greater than the lapsed annual percentage. Two percent of the total annual capital budget has been expensed.

02.24.08 **REVIEW OF THE CHECK REGISTER FOR THE PERIOD ENDED JANUARY 31, 2024 (Action Item 3)** – Mr. Driskell provided information in response to trustees' questions regarding individual expenditures.

02.24.11 NEW BUSINESS

- APPROVAL OF 2024 ILLINOIS PUBLIC LIBRARY ANNUAL REPORT OF 2023 (Action Item 4) - The board approved the 2024 Illinois Public Library Annual Report for 2023 to be filed with the Secretary of State's office.

COMMITTEE OF THE WHOLE

03.24.01 A meeting of the Committee of the Whole of the Board of Library Trustees of the Arlington Heights Memorial Library was called to order in the Richard Frisbie Board Room of the Arlington Heights Memorial Library on Monday, March 4, 2024, at 7:00 p.m. by Vice President/Secretary Andi Ruhl.

Upon <u>**ROLL CALL</u>**, the following answered Present: Trustees Borrell, Galla, Kelly, Medal, Zyck and Ruhl. Trustee Somary participated in the meeting via Zoom due to employment related issues.</u>

Also present: Michael Driskell, Executive Director; Dana Revilla, Deputy Director; Sasha Vasilic, Director of Communications and Marketing; Teresa Katsogianos, Administrative Assistant; Janet Moravec, Executive Administrative Assistant; and Susan Ciano library practicum student at College of DuPage.

Trustee Zyck moved <u>THE BOARD OF LIBRARY TRUSTEES ALLOWS TRUSTEE</u> <u>AMY SOMARY TO ATTEND THE MEETING ELECTRONICALLY DUE TO</u> <u>EMPLOYMENT RELATED BUSINESS.</u> Trustee Borrell seconded. All were in favor and the motion carried.

- 03.24.02 Vice President/Secretary Ruhl led the **PLEDGE OF ALLEGIANCE**.
- 03.24.03 There was no **PUBLIC COMMENT**.
- 03.24.04 **CONSTRUCTION MANAGEMENT SERVICES FOR 2024 RENNOVATION PROJECT (Item 1)** – Executive Director Michael Driskell provided an update on the upcoming 2024 Renovation Project including plans to engage with Shales McNutt Construction (SMC) for construction management services. The anticipated scope of the project includes second floor public area toilet room renovation, first floor Kids' World toilet rooms renovation and basement entry renovation. The committee reviewed a contract with SMC for pre-construction management services, construction management, general liability expense, project staff expense and general expenses. The proposed service estimates from SMC total \$108,538.
- 03.24.05 **LIBRARY PICKUP TRUCK REPLACEMENT** (Item 2) Mr. Driskell provided an update on the replacement of the library's current pickup truck including the budget for a new vehicle and the necessary factors for identifying a suitable replacement.
- 03.24.06 **LASER CUTTER REPLACEMENT (Item 3)** Mr. Driskell reported the staff recommendation to replace the library's Epilog Mini Laser Cutter at the makerspace. It

has been determined it is cost effective to replace the current machine with one from the Epilog Fusion Edge Laser series. The new machine has a larger workspace and is less prone to failure. The Friends of the Library have committed to funding the purchase price of the new laser cutter.

03.24.07 **OTHER**

- Trustee Zyck inquired about customer complaints of postal carrier and delivery issues of the library's monthly newsletter. Sasha Vasilik, Director of Communication and Marketing, reported that he has communicated with the post office and asks staff to report the complaints received from customers to Communications and Marketing so that they are able to track the missing deliveries.

- Mr. Driskell reported on the status of the installation of the cooler tower and chiller replacements. One of the two chiller units received damage during delivery. The damaged chiller will be repaired or replaced with no cost to the library; the library will run on the existing working units.

There being no further business to be discussed, Trustee Borrell moved **<u>ADJOURNMENT</u>**. Trustee Zyck seconded. All were in favor and the meeting was adjourned at 7:37 p.m.

Re: Approval of Contract for Construction Management Services for 2024 Renovation Project

As discussed at the March Committee of the Whole meeting, we will again be working with a construction manager to assist with the bidding process, construction oversight and general project consulting for the 2024 library renovation project. The library has worked with Shales McNutt Construction (SMC) in the past, most extensively during the \$2.8M renovation of the library in 2012 and most recently during the Kids' World Refresh project. Staff recommend that we engage with SMC for construction management services for the 2024 Renovation project based on their excellent reputation, our previous work history and positive experiences working with them. According to the library attorney, a satisfactory working relationship with the contractor permits us to engage with them without going to bid.

The scope of work includes construction consulting services to the library regarding the public bidding, coordination, logistics and communication within the project. SMC will lend expertise and wisdom to the library and the selected contractors for:

1. Pre-Construction Management Services – This phase of the project includes preparation of scope and project development leading up to and including the bid process. SMC will assist in projecting costs for the project, define the scope of the project for contractors, manage the bid process, and provide recommendations of award. Once the design documents are complete, SMC will advise on how to divide the project up for bidding out the main elements, develop the scopes of work, drum up interest in bidding the project from trade contractors, assist the library on bid opening day, and review the apparent low bidder's scope of work for accuracy and grey areas. They will provide a report of findings of this bid review. This part of the proposal is a fixed cost of \$8,000.

- Construction Management SMC will provide subcontractor planning and preparation, pay app review, scheduling of construction, onsite supervision, and general administrative coordination. The construction management fee is 4.75% of the construction costs, estimated to be no more than \$650,000. This fee is expected to be \$30,875.
- 3. General Liability Expense The standard general liability insurance assumes acceptance of the pre-construction services and SMC holding the contracts of subcontractors. The cost for this coverage is 0.75% of the project cost, estimated at \$4,875.
- Project Staff Expense This includes the on-site supervision and administrative related expenses. The cost for the part time supervision is \$12,947/month. Due to the phasing of this project, to accommodate a minimum number of restrooms available to the public throughout the project, we estimate four months of supervision will be needed.
- 5. General Expenses These are the costs associated with managing the project and are not directly attributable to trade contractor bid packages. The General Expenses typically include items such as project information management software (ProCore), general clean up labor, general use dumpsters, general safety reviews / measures, safety inspections, and other similar items. The budget for this item for this project is 2% of the construction costs and is estimated to be \$13,000.

Re:	Authorization of Library Pickup Truck Replacement Purchase

As discussed at the March Committee of the Whole meeting, staff propose to replace the library's pickup truck with a new model. The current truck is a 2010 Ford F250 with 22,850 miles on it and is showing its age through a decrease in reliability. It is used extensively to plow the parking lot and spread salt, which is especially hard on vehicles. The truck experienced extensive repairs in 2023 resulting in a prolonged period of downtime, as many parts are no longer produced by Ford and used parts had to be sourced. After 14 years of service, the truck is at the end of its useful life and should be replaced.

We budgeted \$70,000 in the 2024 budget for the replacement of the pickup truck, and plan to purchase it through the Northwest Municipal Conference (NWMC) purchasing cooperative. We used this cooperative in 2010 when the Ford Transit Connect was purchased. The appropriate options for plowing were selected and a quote was received from Currie Motors in Franklin Park, the holder of the NWMC contract. The proposed truck is a 2024 Chevrolet Silverado 2500, currently in stock at the dealer.

Staff reviewed specifications for Ford, Dodge, and Chevrolet vehicles, including height, drivetrain, included equipment, reviews, cost, and availability. The Chevrolet Silverado 2500 will fit the library's needs best, is below the budgeted amount, and will be provided with a plow and salt spreader from the dealer.

The purchase price for the vehicle is \$52,575, which includes the \$10,000 allowance for the trade in of the current truck and does not include title or licensing fees. We've inspected and test driven the vehicle and it will work well for our needs.

Suggested motion: The Board of Library Trustees approves the purchase of a 2024 Chevrolet Silverado 2500 with a purchase amount not to exceed \$52,575 plus registration and licensing fees.

Re: Authorization of Purchase for Replacement Laser Cutter

As discussed at the March Committee of the Whole meeting, the library's Epilog Mini Laser Cutter is in need of replacement. The cutter has been an integral part of the makerspace, fostering creativity and learning among customers. In 2023 alone, the Epilog Mini was used almost 900 times, making it one of the most heavily used pieces of equipment in the Makerplace. However, due to its high usage and older design, parts have been failing at an accelerated rate. This has led to more frequent and longer downtime, an increase in staff time dedicated to repairs and less availability for customers.

After careful review of the unit, available parts, and cost to maintain, we believe it would be more cost-effective and beneficial to replace the current machine rather than repair it when it fails. We have evaluated many manufacturers of this size and style laser cutter and would like to continue our partnership with Epilog Laser, the manufacturer of our current machine. The specifications of the machine coupled with their commitment to customer service, including 9am-5pm phone support, local vendors for on-site repairs, and overnight delivery of parts when needed, has been invaluable.

We have identified the Epilog Fusion Edge 24 Laser series as a replacement. This machine is a professional/industrial grade laser cutter. It will increase the engraving area from 12x24" to 24x24" and the maximum material thickness from 8" to 10". This new model is not only larger, but more robust, less prone to failure, and offers specific features such as faster speed, and a positioning camera that sets it apart from others in this price range. These new features not only improve efficiency but also make it easier for new users to learn to use the laser.

The new Epilog Fusion includes a two-year parts warranty. This warranty can be extended beyond the initial two years for \$1,200 annually, if we so choose. In our research, we have found the reliability of this model to be excellent. This is evident from the experience of the Elmhurst Library's makerspace, which has not required any repairs in their two years of ownership.

Below is a cost breakdown of the proposed unit:

The lead time for the new laser cutter is approximately three weeks.

After replacement, the plans for the current unit are to use it as a backup or secondary machine. The current secondary laser cutter is a smaller, consumer grade, desktop cutter manufactured by Dremel. While this has been a great tool, the model has been discontinued and parts are no longer being produced. As the Dremel cutter is reaching its end of life, the Epilog Mini will serve as a backup or eventual replacement unit.

The Friends of the Library have committed to the purchase price of the new laser cutter at their February meeting. The library will be responsible for the shipping charges.

Re:	Authorization of Copier Lease Agreement

Library staff are proposing the library enter into a five-year lease agreement with ISBS for the supply and maintenance of copiers throughout the library. The library has traditionally purchased two new copiers each year to replace the oldest units in the fleet and maintains separate service agreements for the upkeep and print costs each month. Due to rising print costs, difficulty finding parts, and compatibility issues with our current software, it is our recommendation to replace the existing copier fleet with all new machines. Our recommendation is to engage in a lease agreement for the costs to purchase, install, maintain, and print for the next five years.

Project Description

This project includes the replacement of eight copiers and two high-volume printers. The copiers are of mixed use for both staff and public consumption throughout the building.

The following copiers and printers are included in the agreement:

- Graphics department copier responsible for producing many of our highquality marketing materials.
- Three copiers to replace the aging fleet in the staff office/administration areas
- Four copiers and the two high-volume printers for customer use in the Digital Services and Genealogy departments

Timeline and Impact

If approved, this project will begin immediately and be completed by April 30, 2024. Due to the number of copiers throughout the library, the impact on the customer is expected to be minimal while we exchange each of the units. Since these copiers are heavily utilized across the organization, there are many benefits to replacing these devices. First and foremost, the reliability and maintenance of

the copiers has become a burden. We often have 2-3 service calls per week related to decreased reliability of the existing units and these calls would all but be eliminated. This will allow customers to complete their business in a timelier manner and eliminate the need for staff to constantly troubleshoot issues.

Financials

The library is currently budgeted to spend \$50,000 annually on replacement, maintenance and consumables of the copiers. Of this amount, \$38,000 is allocated for the printing and maintenance costs with the remaining \$12,000 for the replacement of the oldest copiers. To reduce the cost of our copier program over the next five years (and beyond), we have sought proposals for lease programs that would significantly reduce our expenditure while improving reliability and accessibility for our customers. Assuming no increases in our currently budgeted figures, the budgeted outlook for the next five years is \$250,000. The five-year lease agreement would reduce those costs by almost \$90,000 over the term of the lease.

The library received four proposals from local vendors that expressed interest in providing a lease agreement as well as the accompanying equipment maintenance. As part of the proposal, each vendor was asked to provide a leasing agreement that includes a specific number of pages anticipated to be printed per machine. These figures were calculated based on the average copier use across the library. If printed volumes exceed the volumes included in the lease agreement, a per page fee would increase the total cost of the agreement. Included monthly prints are 32,000 B&W and 28,000 color copies for the eight copier devices. The high-volume printers include 25,000 B&W pages per month.

Soft Launch of New 24/7 Hold Pickup Lockers

The library's new 24/7 Hold Pickup Lockers softly launched to customers on Monday, February 19, offering customers a convenient location to pick up items any time. When placing holds customers will now see the lockers as a pickup option, along with an ADA option. Circulation Staff have been training and testing the lockers over the last month to ensure the process goes smoothly.

The lockers webpage is live on the library's website under About > Using the Library. The webpage features information on how to place a hold for locker pickup, how to pick up a

hold at the lockers and frequently asked questions. The Communications & Marketing team is collaborating with the Circulation Supervisors on a video tutorial on how to use the lockers which will be posted in April. More information about the official launch will be featured in the library's April newsletter.

The library's 24/7 Hold Pickup Lockers have been generously funded by Gallagher Insurance through a donation to the Arlington Heights Memorial Library Foundation.

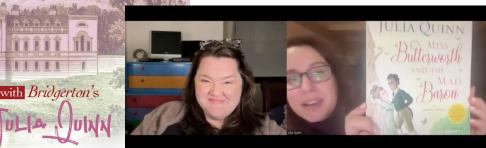
Staff Continue to Offer Virtual & Hybrid Opportunities

Barb, Info Services Librarian, is serving on the 2024 Business Interest Group Financial Fitness Planning Committee, a regional group of libraries coordinating to plan personal finance programs in the fall.

Jennifer, Programs & Exhibits Manager, continues her work with LACONI (Library Administrators Council of Northern Illinois) as a member of the LACONI SAAM (Supervisors, Administrators and Managers) board.

Traci, Finance Manager, used the Makerplace Kitchen to prepare her famous chili which was entered in the Arlington Lion Club Annual Chili Cookoff on behalf of the library. While the chili did not defend its first-place title from last year, the event did raise funds to directly benefit our community. Library staff also volunteered to serve the chili at the event.

Grow the use of our services and resources

Meet Manny, the Makerplace 3D Printed Robot

Visitors to the Makerplace often express curiosity about the workings of 3D printing. While we often have community 3D prints in progress that customers can observe, there are times when this is not possible. To address this, we've typically used sample 3D print files, but none of these were unique to the Makerplace.

Chris, Makerspace Branch Assistant Manager, recognized this gap and designed a unique 3D print file. Drawing inspiration from Nir Dobovizki's "Articulated Robot In 10 Minutes," Chris enhanced the design by adding a Makerplace logo and LEGO-compatible hands. This resulted in a quick print that is not only intriguing to watch, but also fun to play with later. Named Manny, this robot can be printed in under 15 minutes and serves as an excellent demonstration of 3D printing technology for all ages.

The file has been added to all Makerplace printers as a demo and is also available on Printables.com. This allows the wider 3D printing community to download, print, remix and share this unique design.

Three New Culinary Classes (Six Sessions!) Offered

Andrea Pracht of My Kitchen Clatter joined us for backto-back sessions on making delicious pizza at home. Thirty attendees participated—many new to the Makerplace Kitchen. Participants loved the hands-on elements of the class and always appreciate Andrea's generous instruction and encouragement to try the recipe again at home.

Chef Grace Goudie was back with two hands-on sessions on how to make beef stroganoff. Eighteen customers

attended the afternoon session and 17 attended the evening session.

Chef Julie Yoon taught two sessions of her hands-on *Chicken Teriyaki for Two* class to 31 student chefs. Chef Julie loves teaching beginners how to use basic skills to create delicious meals and build confidence in the kitchen.

Increased Usage of the Hub Study Rooms

The use of the new Hub Study Rooms nearly doubled from 33 uses in January to 63 in February. This is only the second full month that the rooms have been available for teens. Teens use the rooms to work on group projects,

play games together, have study sessions where they work through problems together on the dry erase boards and as a place to complete independent work.





New Adult Program Brings Community Together Around Same Interest

Nineteen customers attended a hands-on lesson in guitar fingerpicking hosted by Jay from Programs & Exhibits. Our guest instructors were Nahum Smith and Al Costis of local El Rey Music Center. The program attracted many male attendees—more than we typically see at library programs. Survey results indicated attendees would like more similar opportunities.

MVPs Host Successful First Winter Carnival

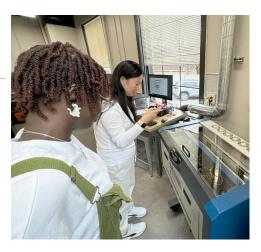

The Youth Services department

hosted two cake pop classes for kids ages 4-6 with their grownups. Each child mixed ingredients, formed cake balls and dipped them in melted chocolate, developing their fine motor skills. With two sessions offered, 30 total attendees had a sweet experience with take-home treats for their family members.

of Lorain, Ohio through her brilliant career as one of America's most important authors. The enthusiastic audience of 12 attendees enjoyed the opportunity to learn more about Morrison's life and to view the film with neighbors. Survey results indicated that attendees are grateful AHML offered a robust series of ways to celebrate Black History Month.

Autodesk Foundation Grants Makerplace \$195,500 Worth of Software Licenses

Chris, Makerspace Branch Assistant Manager, successfully collaborated with the Autodesk Foundation to secure the renewal of a three-year software donation contract. This renewed contract grants the Makerplace access to 20 licenses of the Autodesk Product Design & Manufacturing Collection. The donation, valued at \$9,795 per license, culminates in a generous total contribution of \$195,500. As a result of this agreement, Makerplace customers will benefit from the use of premier 2D and 3D design tools, including renowned industry software such as AutoCAD and Fusion360.

Weekly Current Events Discussions Makes a Difference

The Arlington Heights Senior Center Current Events group hosted by the library's Senior and Accessible Services department marked the start of their 35th year of weekly discussions. Multiple participants said the group is not just a place to discuss, but also to connect with others and ponder other points of view. Following a recent agenda topic about the epidemic of loneliness in men, a group of men stayed after the program to organize going out to dinner together. The following week, another participant thanked the library for selecting the topic about



loneliness in men because in response her husband (who also attends) reached out and called an old friend.

Collection Services Meets Popular Demand

The Collection Services department strives to make the library's collections community-responsive to make sure that we have high-interest materials and materials that our customers look for and love. Occasionally, when a particular collection or type of material is very popular and has a very high percentage of items always checked out, Collection Librarians will intentionally add several extra copies or similar materials to meet the demand of these collections.

The Dinosaur Picture Books are one of our most popular collections—approximately 78% of this collection is always checked out. In February, Collection Librarians added 70 additional dinosaur picture books to the collection—an increase of 30%. Nearly all of these titles have already been checked out!

Library Provides New Way for Emerging Adults to Engage

The Programs & Exhibits department hosted a RPG (Role-Playing Games) afternoon for adults. Game Masters from Rough Magic Games ran five different Dungeons and Dragonsbased RPGs for 18 players of various experience levels. The four-hour program attracted people who play Dungeons and Dragons games regularly, some who hadn't played in over 10 years, and others who were interested in learning the basics.



Big Crowds for Little Miss Ann Concerts

Youth Services hosted Little Miss Ann for two shows on February 17. Nearly 80 participants joined us for the Our Time Celebration/supported show. One of the caregivers expressed that this was a big deal family outing for them. They were excited to make memories and have a safe place to go.

One hundred eighty-nine customers enjoyed the second show, including a Filipino family that shared they were so happy to see their culture represented at the library.



Increase in Resume Reviews This Month

This month our professional resume reviewers completed 15 resume reviews. Customers routinely provide positive feedback and share how the review helped them obtain a job. A comment below from a recent customer: "*After being laid off mid-November, I am starting a new position on Friday, March 1. This position is more attractive than the one I previously held having a comparable base salary, more upside on the commissions structure, and equity options. This will be a stronger learning environment where I can leverage more of my skills and experience more professional development."*



More Than Fifty Customers Attended Needle Felting Programs

Needle Felting has always been a popular class at the Makerplace, and for good reason. Natasha Lehrer Lewis of Esther's Place brings locally sourced supplies and a wealth of knowledge to every class. In anticipation of demand, Makerspace Specialist Kate led two additional sessions, allowing customers on the waitlist a chance to attend sessions a week later. A total of 51 customers attended the programs, commenting "*Hove that you used a staff presenter in order to make additional sessions available.*"

Update on Tax Services Usage

In February, AARP volunteers completed 199 tax assistance appointments. Of these appointments, 123 were with Arlington Heights residents. From the tax table near the Info Desk, 4,275 forms/instructions were distributed to customers and 28 books circulated from the display. An additional 2,905 sheets were printed from the tax station near the Dunton entrance.

Customer Hosts Women Breaking Barriers Panel in Hendrickson Room

One of our younger customers, Cecilia, and her mother used the Hendrickson Room to present *Women Breaking Barriers at Work and in the Community*. Cecila hosted the panel discussion which included accomplished local women who talked about their experiences working and serving in traditionally male roles.





More New Displays Added

In Case You Missed It is a new display to highlight titles being moved out of New & Popular. The display unit is near the Info Desk and is one of the new ones purchased this year. In the first week, 40 items circulated off the display. The Collection Services department added three displays in Kids' World to highlight kids' nonfiction and increase circulation. This display will have rotating high-interest topics and be maintained by Collection Services staff. The first three topics are: *Dinosaurs, Under the Sea* and *People You Should Know*. In the first two days, 16 items were circulated off the display, with several more being used in-house.

Another Successful PADS Meals Prep

In February, AHML hosted another successful PADS (Public Action to Deliver Shelter) Meal Prep program. The participants orchestrated the preparation of dinner, dessert and packed lunches for 50 individuals in need. Since PADS Meal Prep began on MLK Day in 2023, 430 meals total have been prepared by our community over six sessions—215 lunches and 215 dinners. Over the course of this series, several attendees have been ignited by the simplicity and joy of the format and expressed interest in hosting their own PADS Meal Prep events with their churches or blocks.

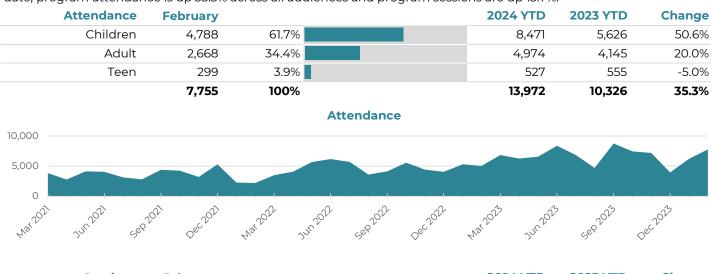

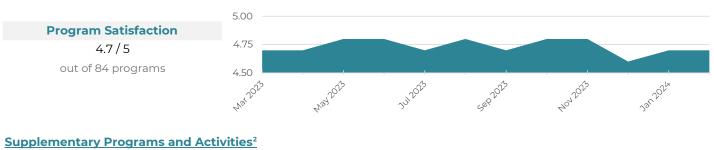

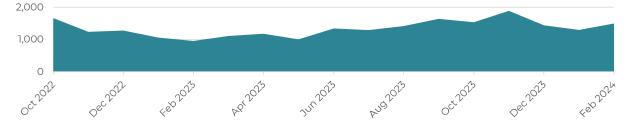
